

**THE 2063<sup>RD</sup> REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES

The 2063<sup>rd</sup> regular meeting of the President and Board of Trustees was called to order by President Peter N. Silvestri on Monday, November 16, 2009 at 7:00 p.m. in the Village Chambers.

#### **PRESIDENT'S REPORT**

President Silvestri proclaimed November 15 - 21, 2009 as National Hunger and Homelessness Awareness Week and encouraged all citizens to recognize that there are homeless individuals and families in our community who need the support of their fellow citizens and from the private and public nonprofit agencies that serve them.

This group meets weekly at the Grace Lutheran Church on Harlem Avenue. No Board action required.
