RE: Freedom of Information Act Request

Dear Mr/Ms. Moinkhan

The Village of Elmwood Park is in receipt of your April 6, 2016, Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") for the following records:

"Please check and advise for : 1) liens special assessment, 2)open code violation, 3) open/expired building permit and any Address: 3114 North 78th Avenue Elmwood Park, Cook, IL 60707, 12-25-103-034-0000."

Enclosed are records responsive to your request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee id number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses." Section 7(1)(c) of FOIA provides that, "personal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy is exempt from disclosure. Consequently, birthdates and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, such as the victim's name and identifying information, have been redacted from the records being provided.

In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office.



AN ORDINANCE DISSOLVING
SPECIAL SERVICE AREA NOS.
ONE, TWO, THREE, FOUR, FIVE, SIX, SEVEN,
EIGHT, NINE, ELEVEN AND TWELVE
OF THE VILLAGE OF ELMWOOD PARK

WHEREAS, the corporate authorities of the Village of Elmwood Park previously established Special Service Area Nos. One, Two, Three, Four, Five, Six, Seven, Eight, Nine, Eleven and Twelve by the adoption of Ordinance Numbers 93-55, 93-56, 93-57, 93-58, 93-59, 93-60, 93-61, 93-62, 93-63, 93-65 and 93-66, respectively; and

WHEREAS, each of said ordinances which established the various Special Service Areas provided, in Section 5 thereof, authorization to levy a special tax annually for a maximum of five (5) years; and

WHEREAS, said five (5) year period for levying the special tax has expired and the corporate authorities do not intend to levy any additional special tax, on account of the special purpose of said tax having been satisfied.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Elmwood Park, Cook County, Illinois, that Special Service Areas Nos. One, Two, Three, Four, Five, Six, Seven, Eight, Nine, Eleven and Twelve, as further described in Exhibit A attached hereto, are hereby dissolved and extinguished, and no further special taxes shall be levied with regard to said Special Service Areas enumerated hereinabove.


