Re: Freedom of Information Act Request

Dear Cameo Towers Condo Association:

On August 17, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"POLICE REPORT # 16-01964 FOR OFFICER VISIT TO THE CAMEO TOWERS, 7234 W. NORTH AVENUE, ON FRIDAY, AUGUST 12, 2016 @ 1 PM[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including home or personal telephone numbers, and home addresses, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, a birthdate, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including the name of a suspect who was never arrested, and the races of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency

for law enforcement purposes” are exempt from disclosure, “but only to the extent that disclosure would: ... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies.” Consequently, information that would reveal the identity of persons who filed complaints with or provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. You can file your Request for Review with the Public Access Counselor by writing to:

If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

On 08/12/16, at approximately 2147 hours, I was dispatched to the Elmwood Park police station lobby for an Information for Police call.

Upon arrival, I spoke with [REDACTED] (F, DOB [REDACTED]) who said she had a verbal confrontation with her maintenance man, [REDACTED] (M, 30-35 YOA.) [REDACTED] said she owns a condo unit at Cameo Towers and was planning on having a dishwasher installed when she was confronted by [REDACTED] said [REDACTED] was irate because [REDACTED] had the dishwasher delivered on the wrong date, which was 08/05/16. She said [REDACTED] became very angry and screamed at her in the lobby saying, "You're not even American and get the fuck out of here." [REDACTED] believed [REDACTED] was having a bad day but there was no reason to talk to her like he did. She said she has had some issues with him in the past but they never escalated to this level. [REDACTED] said the confrontation never became physical nor was she in fear for her safety.

I advised [REDACTED] I would document the incident and for her to contact the building manager regarding [REDACTED]. I told her to stay away from [REDACTED] until she gets the chance to speak with someone from Cameo Towers.
