Re: Freedom of Information Act Request

Dear Mr. Rogel:

On August 15, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") request for "16-1983[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including home or personal telephone numbers, and home addresses, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including the name of a third party that incidentally appears in a police report, and the races of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes" are exempt from disclosure, "but only to the extent that disclosure would:

... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies." Consequently, information that would reveal the identity of persons who filed complaints with or provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. She knows only as a friend of her ex-boyfriend, explained that she dated and lived with two years ago, and borrowed money from to obtain furniture for their apartment. was paying back, but she did not know how much had been borrowed or how much had repaid to . She said she did not know why was coming to her for the money, when he had been loaning money to the entire time. She asked how she could obtain an order of protection against I explained the process of obtaining an order of protection to an and gave her the report number. I told her the money issue between her and was civil, and could not be handled by police. I advised her to call police if comes to her residence uninvited. left EPPD. I spoke to using Auxiliary Officer Robles as an interpreter. said two years ago, was living with his now ex-friend, . He loaned she could retrieve her impounded vehicle. He also co-signed a loan for her to obtain \$1600 in furniture from a local furniture store. He has not received any type of repayment from or since in the two year period since.
