Freedom of Information Act Request

Dear Mr. Mullally and Ms. Lihota:

The Village of Elmwood Park is in receipt of your January 29, 2016, Illinois Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") request for the following records:

"Police Report, Incident Report, and or Arrest Report of allegedly being stopped by Elmwood Park Police.

D/O/I/ 12/01/2015 at 12:30am to 2:00am Afrain Gomez, ... [.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(a) of FOIA provides that, "[i]nformation specifically prohibited from disclosure by federal or State law or rules and regulations implementing federal or State law" is exempt from disclosure. Section 1240.80(d) of Title 20, entitled "Corrections, Criminal Justice, and Law Enforcement," of the Illinois Administrative Code provides that, "LEADS data shall not be disseminated to any individual or organization that is not legally authorized to have access to the information." Consequently, information obtained through the Law Enforcement Agencies Data System ("LEADS") has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and

personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, a driver's license number, home addresses, and a personal license plate, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including the name of a third party property owner who incidentally appears in police reports, and the races of individuals, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. On 12/01/15 at 0018 hours while backing up Officer Weiss on a traffic stop on the 7600 block of Grand Ave, I observed II regularized traveling eastbound with no headlights and heavy front end damage. As the vehicle passed me, I observed sparks coming out from the bottom of the vehicle. I activated my emergency lights and curbed the vehicle on the 7600 block of Grand Ave.

I approached the vehicle and made contact with the driver now identified as Afrian Gomez, Marchael and requested his license and proof of insurance. Gomez was able to produce both.

Officer Hock arrived on scene. Officer Hock and I walked to the front of the vehicle to assess the damage. Officer Hock and I observed heavy front damage, and a bicycle lodged under the front bumper.

I returned to Gomez and asked where he was coming from. He told me he just left work at the UPS hub on 25th Ave in Franklin Park. I asked Gomez what happen to his vehicle and he told me he just left work and hit a car in the parking lot. I then asked Gomez to explain the Bicycle lodged under the bumper and he said, "I'll be honest, I hit a person." I asked if he stopped to check on the person and he told me no because he was scared.

I immediately had WESCOM notify both River Grove and Franklin Park to look for an injured subject. Gomez informed me he struck the person in the area of 25th Ave and Fullerton Ave in Franklin Park. I notified WESCOM of this information. Back in my squad, unit 345, a check though LEADS revealed

WESCOM notified me Franklin Park had located a possible victim. I asked Gomez to step out of the vehicle, at which time he was placed into handcuffs, double locked and checked for fit, and detained until Franklin Park Officers could arrive at my location.

Franklin Park Officer Adamski arrived on scene and took Gomez into custody. Franklin Park Officers arrived on scene to photograph, tow and seize the vehicle.

There is nothing further to report at this time. I returned to active patrol.
