Re: Freedom of Information Act Request

Dear Mr. Sheehan:

The Village of Elmwood Park is in receipt of your February 4, 2016, Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "16-271[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, home or personal telephone numbers, and home addresses, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the races of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, “[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes” are exempt from disclosure, “but only to the extent that disclosure would: ... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies.” Consequently, information that would reveal the identity of persons who filed complaints with or who provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

ON 02/03/2016 AT APPROXIMATELY 1349 HOURS I RESPONDED TO 2826 74TH AV FOR A REPORT OF A BURGLARY. UPON ARRIVAL I MET WITH [REDACTED] (M [REDACTED] AND [REDACTED] (F [REDACTED]). INVESTIGATION REVEALED THE FOLLOWING:

ON 02/03/2016 BETWEEN 1000 - 1245 HRS, AN UNKNOWN SUBJECT(S) MADE FORCED ENTRY INTO THE SIDE ACCESS DOOR OF THE [REDACTED] GARAGE AND REMOVED SEVERAL ITEMS THROUGH THE OVERHEAD DOOR INTO THE ALLEY. [REDACTED] WAS HOME DURING THE DAY BUT DID NOT HEAR OR SEE ANYTHING. THE ITEMS ARE DESCRIBED AS:

- TORO SNOW BLOWER (RED) - \$200 USC
- HUSKEY TOOL SET (RED/BLACK) - \$150 USC
- RIDGID SAWZALL (ORANGE) - \$120 USC
- DEWALT TABLE SAW (YELLOW) - \$500
- SHOP VAC WET VAC (RED/BLACK) - \$80

IT APPEARS THE SIDE DOOR WAS KICKED SEVERAL TIMES UNTIL THE DOOR JAM SEPARATED. THE OVERHEAD DOOR WAS LEFT AJAR. THE SNOW BLOWER WAS REMOVED FROM THE SOUTH WALL OF THE GARAGE BUT A LAWN MOWER WAS LEFT UNTOUCHED. THE TOOLS WERE REMOVED FROM A SHELF ON THE NORTH WALL.

OFFICER LAPENNA ARRIVED ON SCENE BUT WAS UNABLE TO PROCESS THE SCENE FOR EVIDENCE. OFC LAPENNA SPOKE TO NEIGHBORS AT [REDACTED] AND [REDACTED] WHO WERE NOT HOME DURING THE ABOVE HOURS. I SPOKE WITH RESIDENT OF [REDACTED] (TX: [REDACTED] HAS SEVERAL SECURITY CAMERAS INSTALLED IN THE ALLEY. [REDACTED] STATED HE WILL REVIEW THE TAPE AND PROVIDE INVESTIGATIONS WITH A COPY.
