Re: Freedom of Information Act Request

Dear Ms. Rodriguez:

On July 15, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request. Enclosed please find the records responsive to your FOIA request. Please be advised that on July 15, 2016, the Village of Elmwood Park attempted to send these records electronically to sdela1229@gmail.com; however, the email was unable to be delivered. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including driver's license numbers, home or personal telephone numbers, home addresses, and personal license plates, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, birthdates, and other personal information,

the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including the names of third parties who incidentally appear in police reports, and the races of individuals, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

On 05/26/16, at 2003 hours, I was summoned to the Elmwood Park Police station for a drug investigation report. Upon my arrival, I spoke with the complainant, Blanca Rodriguez, f [REDACTED] who told me the following in summary:

I advised Blanca to contact our agency immediately if further activity is observed.

On 07/08/16, at 1220 hours, PPO Dressner and I responded to the Elmwood Park Police Department for a burglary report, later classified as disorderly conduct.

Upon arrival, I spoke to Blanca Rodriguez in the report room. Blanca told me in summary: Blanca rents an apartment unit to Esma Ukoja. Since Esma moved in, she has invited many people over and constantly violates the lease agreement. This morning at about 0240 hours, Esma, her son "Ray" aka Esad Kobic and another unknown male were in the common area stairwell of the building yelling in the direction of Blanca's unit "If you call the police, I'll kill you, your son and daughter." Blanca said at least one of the three kicked her unit door. Blanca told me her family is scared to live in her own home.

I attached a photograph to this report given to me by Blanca. Blanca requested a special watch for her residence.

On 04-30-16 at 1918 hours, Ofc Schak and I responded to 2632 72nd Court for a meet complainant call.

On scene we spoke to building owner and first floor resident Biacna Rodriguez. Bianca told us she has a lease with Esma Ukoja and her two children for the 2nd floor unit of her building. Bianca says Esma has violated their lease agreement in numerous ways and she has previously served them with a "10 day notice to vacate form" per the Cook County Sherrif's Office. Bianca said today is the 10th day and they made no efforts to leave. Bianca believes a 24yo male who may now reside in the unit is selling drugs from her property. Bianca says this occurs in the front an back of the building, and the male will usually exit the unit and meet people in the street or in the gangway. Bianca says at all hours of the day and evening various people are coming and going from inside the unit. She is not sure what specific drugs are being sold. She also suspects there may be prostitution being done inside this unit.

Bianca is concerned for her safety when the occupants actually leave the premise and she would like an increase in patrols in the area to watch for suspect illegal activity.

I advised her to contact us when these illegal activities are occurring and to follow up with the Sherrif's office to continue on with the eviction process.
