Re: Freedom of Information Act Request

Dear Ms. Ukoja:

On June 28, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "16-1537[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a home or personal telephone number, and a home address, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, a birthdate, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy,

including a victim's name and identifying information, the name of a third-party property owner, and the race of an individual, have been redacted from the records being provided.

In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. 

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

ON 06/27/2016 AT APPROXIMATELY 1616 HOURS, I WAS DISPATCHED TO THE STATION TO MEET WITH [REDACTED] (F [REDACTED]) REGARDING A REPORT OF A BATTERY. [REDACTED] STATED THE FOLLOWING IN SUMMARY:

ON TODAY'S DATE, [REDACTED] WAS IN COURT REGARDING AN EVICTION FROM [REDACTED] WAS INFORMED SHE DID NOT HAVE TO VACATE THE PREMISE. [REDACTED] HAS HAD ONGOING ISSUES WITH HER LANDLORD, [REDACTED] WHICH HAVE BEEN DOCUMENTED ON NUMEROUS OCCASSIONS BY THIS DEPARTMENT.

AT APPROXIMATELY 1530 HOURS, [REDACTED] WAS WALKING WESTBOUND ON 7200 DIVERSEY WHEN SHE WAS APPROACHED BY 2 UKNOWN SUBJECTS. THE SUBJECTS WERE DESCRIBED AS FOLLOWS:

1ST SUBJECT - M/W-H, APPROXIMATELY 30-40 YEARS OF AGE, 601 HEIGHT, 250 LBS, LONG DIRTY BLONDE HAIR, LONG DIRTY BLONDE BEARD, WEARING JEANS WITH BLACK BOOTS, A BLACK LEATHER VEST, AND A BABY BLUE BANDANA AROUND HIS HEAD.

2ND SUBJECT - M/W-H, APPROXIMATELY 30-40 YEARS OF AGE, 601 HEIGHT, 250 LBS, LONG DIRTY BLONDE HAIR, SHORTER DIRTY BLONDE BEARD, WEARING JEANS WITH BLACK BOOTS, A BLACK LEATHER VEST, AND A BABY BLUE BANADANA HANGING OUT OF HIS BACK POCKET.

THE SUBJECTS FORCED [REDACTED] INTO THE 2800 ALLEY OF 72ND CT BEHIND THE FENCE WHICH RUNS ALONG THE WALGREENS PARKING LOT. THE FIRST SUBJECT BEGAN TO CHOKE [REDACTED] BY PLACING BOTH OF HIS HANDS AROUND HER NECK. THE FIRST SUBJECT STATED, "YOU NEED TO MOVE OUT! THIS IS A WARNING! EVERYONE WILL DIE IF YOU DON'T MOVE OUT!"

THE FIRST SUBJECT THEN GRABBED [REDACTED] BY THE ARMS AND PUSHED HER UP AGAINST THE FENCE AS THE SECOND SUBJECT ACTED AS A LOOK OUT. THIS ENTIRE INCIDENT LAST APPROXIMATELY 6-7 MINUTES.

[REDACTED] BELIEVES SHE WOULD RECOGNIZE THE SUBJECTS IF SHE SAW THEM AGAIN. I OBSERVED NO INJURIES TO [REDACTED] NECK OR ARMS THAT WOULD INDICATE SHE WAS CHOKED OR BATTERED.

I RELOCATED TO THE AREA OF 7200 DIVERSEY TO CONDUCT A CANVASS. SEVERAL BUILDINGS ON 72CT HAVE SECURITY CAMERAS ON THE REAR OF THEIR BUILDINGS THAT ARE DIRECTED TOWARD THE ALLEY.
