**Re: Freedom of Information Act Request**

Dear Ms. Chaudhary:

On July 18, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "16-1697[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a home or personal telephone number, and home addresses, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, a birthdate, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy,

including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. 

On 07/14/16, at approximately 0337 hours, I was dispatched to a Theft under \$500 call at Schubert and 78th Court.

Upon arrival, I spoke with [REDACTED] (F/M), DOB [REDACTED] who said an unknown, white male exited her taxi (IL Reg- 608TX) without paying the fare. [REDACTED] said the male was approximately 6 feet tall, with a medium build and walked into the backyard of [REDACTED]. She said the male told her he needed to get money from his friend but never came back to pay her once he entered the yard. [REDACTED] believed he entered [REDACTED] and fell asleep. [REDACTED] wanted to sign a complaint for theft if the subject was apprehended. She stated there is in-car video which she would copy and drop off to the Elmwood Park CID. The total amount lost was \$53.50 US currency.

Officer Marchi and I attempted to make contact with the resident of [REDACTED] but were unsuccessful. I advised [REDACTED] of her report number and to drop off the video as soon as possible.
