Re: Freedom of Information Act Request

Dear Ms. Vasquez:

On July 11, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "16-1546[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a home or personal telephone number, and a home address, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, a birthdate, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including the race of an individual, has been redacted from the records being provided.

In summary: On this date at 1014 hours I was dispatched to the police station for this incident report. When I arrived I spoke to Maria Vasquez. Maria told me, on or before 27 May 2016 she received a late payment notice from Direct TV in the amount of \$601.01. Maria told me, she called Direct TV and told them she never received or ordered their service. The customer service representative told Maria an account was opened at unknown time under her name under account number 57414736. Maria told me, on 17 Jun 2016 she received a collection of debt from Convergent Outsourcing stating she is in collections for lack of payment to Direct TV. Maria told me, she contacted them and they told her she needs to file a police report stating she never ordered the service from Direct TV. Maria showed me papers needed to be filled out and sent back for Identity Theft. R/O gave Maria the Police report number from this agency.
