Dear Ms. Gorgoni:

On June 9, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "16-01214[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(a) of FOIA provides that, "[i]nformation specifically prohibited from disclosure by federal or State law or rules and regulations implementing federal or State law" is exempt from disclosure. The Illinois Juvenile Court Act of 1987 (705 ILCS 405/1 *et seq.*) mandates that reports in which a minor was arrested, charged, or investigated must be withheld in full. Section 1-7(A) of the Illinois Juvenile Court Act of 1987 specifically provides that, "[i]nspection and copying of law enforcement records maintained by law enforcement agencies that relate to a minor who has been investigated, arrested, or taken into custody before his or her 18th birthday shall be restricted" to specifically enumerated individuals whose access to such records is necessary for the performance of their official duties. Your FOIA request seeks information which is prohibited from disclosure pursuant to the Illinois Juvenile Court Act of 1987. Consequently, information that is prohibited from disclosure pursuant to the Illinois Juvenile Court Act of 1987 has been redacted from the records being provided.

Your FOIA request also seeks records obtained through the Law Enforcement Agencies Data System ("LEADS") which are prohibited from disclosure pursuant to Section 7(1)(a) of FOIA. Section 1240.80(d) of Title 20, entitled "Corrections, Criminal Justice, and Law Enforcement," of the Illinois Administrative Code provides that, "LEADS data shall not be disseminated to any individual or organization that is not legally authorized to have access to the information." Consequently, information obtained through LEADS has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including driver's license numbers, home or personal telephone numbers, home addresses, personal license plates, and signatures, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, the name of a suspect who was never arrested, the names of third parties who incidentally appear in police reports, and the races of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes" are exempt from disclosure, "but only to the extent that disclosure would: ... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies." Consequently, information that would reveal the identity of persons who filed complaints with or provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information



On 05/25/16, at 0146 hours, I responded to the intersection of Belden Avenue and 75th Court, for a reported fight in progress.

I arrived at the location with Officer Marchi, and saw seven subjects on the parkway, sidewalk, and front lawn at 2238 75th Court.



I spoke to the following subjects, who remained at the location:



Marchi dispatched the white truck information to EPPD units, and advised the vehicle contained offenders involved in a reported Battery.



I asked [redacted] to explain what had happened.



[redacted] While sitting inside [redacted] car, an unknown white truck pulled up in the street next to them. [redacted] exited his car, and began talking to the unknown driver of the truck about being too close to his new car. Lucy exited the white truck and began pounding on the passenger door and glass of [redacted] car, where [redacted] was seated. [redacted] arrived at the location, grabbed Lucy around the waist, from behind, and pulled Lucy away from [redacted] vehicle.

I spoke to [REDACTED]

[REDACTED] He drove over to [REDACTED] house. When he arrived at [REDACTED] house, he saw [REDACTED] talking to someone in a white truck. Lucy got out of the white truck, and opened the passenger door of [REDACTED] car. After opening the passenger door, Lucy began hitting [REDACTED]. He wanted to protect his girlfriend, so he ran over to Lucy, grabbed her around the waist, and pulled her away from [REDACTED]. Lucy began punching him, and he said, "Hit me. Just don't hit [REDACTED]" He was not injured by any of Lucy's punches.

[REDACTED]

[REDACTED] reported no injuries, and stated he did not want to sign a complaint against anyone.

I asked [REDACTED] for a description and information for Romero.

[REDACTED] said, "I only know his first name is Romero. I think he was a year younger than me in school (Elmwood Park High School), so I think he's twenty" years old. He could not give any additional description. He said he did not recognize the white pick up truck that had been there at the start of the fight, and was not sure if Romero had driven the truck, or had also been a passenger in the truck.

I asked [REDACTED] why he had given [REDACTED] a baseball bat prior to the incident, when he had been told everyone was going to be talking about their issues on Twitter.

[REDACTED] said he did not give [REDACTED] his baseball bat. He said [REDACTED] must have taken it out of his car, where he keeps it under the seat for his softball games.

I told [REDACTED] that [REDACTED] stated he had given her the bat prior to the incident, and that she had it inside [REDACTED] car with her, when [REDACTED] and [REDACTED] arrived.

[REDACTED] said he "may have" given [REDACTED] the bat earlier, because [REDACTED] was talking about meeting [REDACTED] and Lucy to settle their dispute, [REDACTED]. He was actually surprised at Lucy's violence, because Lucy is normally calm. [REDACTED]

I spoke to [REDACTED]

[REDACTED] said he and [REDACTED] were sitting in his car talking. A white pick-up truck pulled up extremely close

to his car. He exited his vehicle and began talking to the driver, known to him only as "Romero." He was talking to Romero, complaining about almost striking his new car. [REDACTED]

Officer Loni advised he had stopped Lucy and [REDACTED] and that the driver of the white truck had run away from the stop.

I told Loni to bring Lucy and [REDACTED] to EPPD, as they were reported Battery offenders, and ordered the truck to be towed.

I told [REDACTED] to go to EPPD so I could investigate the incident further.

I transported [REDACTED] to EPPD, and called paramedics to check her injured forehead.

While Officer Borrini was completing a prisoner property inventory sheet for Lucy, she was found to have a small amount of Cannabis in her pocket, wrapped inside a foil cigar wrapper.

Lucy said [redacted] and [redacted] had been "talking shit" about her, and her drug rehab, on Twitter. [redacted] sent her a message on Twitter, saying he wanted to "talk it out." She decided to go meet [redacted] and [redacted] at their friend [redacted] house. [redacted] friend, known only to her as "Rambo," offered to drive her and [redacted] to [redacted] house. When they arrived at [redacted] house, she got out of the truck and walked over to [redacted] got out of his car, and she could see he was angry. [redacted] punched her from behind, grabbed her by her arm, twisted it, and pushed her to the ground. [redacted] got out of [redacted] car with a baseball bat. [redacted] got out of the truck, and [redacted] started swinging the baseball bat at "everyone." [redacted] grabbed the baseball bat, took it away from [redacted] and threw it down on the ground. "Everyone was fighting," [redacted] had "sucker punched" both her and [redacted] and she "was hitting [redacted] hard." When the police came, [redacted] said, "Run," so she ran to "Rambo's truck." When the police stopped the truck, "Rambo" got out and ran away for no known reason. Lucy said she was not injured during the incident, and did not want to sign a complaint against anyone.
