Dear Mr. Gable:

On March 17, 2016, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

- "- Police report 16-292
- involving incident on 2/6/16 at 2843 N. 75th Ct
- involving Diadean Mohamed[.]"

Enclosed are the records responsive to your FOIA request. Please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a driver's license number, home or personal telephone numbers, and home addresses, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, “[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy” is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim’s name and identifying information, and the races of individuals, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. 

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

ON 02/06/16, OFC LOMBARDI AND I RESPONDED TO A NEIGHBOR DISPUTE AT 2843 75TH CT #1.

UPON ARRIVAL, I SPOKE TO THE COMPLAINANT, [REDACTED] (F [REDACTED]). [REDACTED] STATED SHE IS HAVING AN ONGOING ISSUE WITH HER NEIGHBOR, DIADEAN MOHAMMAD [REDACTED] STATED AT APPROXIMATELY 0720 HOURS, DIADEAN STOOD IN FRONT OF HER DOOR AND BEGAN TO YELL SWEAR WORDS. [REDACTED] STATED DIADEAN BEGAN INSULTING HER RELIGION AS WELL. [REDACTED] STATED SHE FEARED FOR HER SAFETY BECAUSE SHE WAS HOME ALONE WITH HER 5 CHILDREN AND DIADEAN WAS STANDING DIRECTLY IN FRONT OF THE DOOR TO HER RESIDENCE. [REDACTED] STATED SHE BELIEVED HE MIGHT ATTEMPT TO ENTER HER RESIDENCE BECAUSE OF HOW ANGRY HE WAS AT HER. I SPOKE TO ONE OF HER CHILDREN WHO STATED HE WAS AWOKEN SEVERAL TIMES BY THE DISTURBANCE.

I MADE CONTACT WITH DIADEAN IN FRONT OF THE ENTRANCE TO TO HIS APARTMENT. DIADEAN REFUSED TO STEP INTO THE HALLWAY TO SPEAK TO ME. I SPOKE TO DIADEAN THROUGH A SMALL OPENING IN THE DOOR. HE DENIED ALL OF [REDACTED] ACCUSATIONS.

I RETURNED TO MY VEHICLE TO WAIT FOR THE PROPERTY OWNER/LANDLORD TO ARRIVE ON SCENE.

UPON HIS ARRIVAL HE INFORMED ME THAT HE HAS HAD SEVERAL ISSUES WITH DIADEAN AND HAD ALREADY BEGAN THE EVICTION NOTICE.

OFC LOMBARDI SPOKE TO [REDACTED] STATED SHE TRIES HER BEST TO AVOID DIADEN, BUT CONTINUES TO HAVE ISSUES WITH HIM.

[REDACTED] SIGNED A CODE VIOLATION TICKE FOR DISORDERLY CONDUIT.

I ATEMPTED TO ISSUE DIADEAN THE TICKET AND PROVIDE HIM WITH THE HEARING INFORMATION.

DIADEAN TOLD ME HE WOULD NOT ACCEPT ANY DOCUMENTS UNLESS I STEPPED IN FRONT OF HIS DOOR SO THAT HE COULD RECORD ME. FEARING THE POSSIBLITY OF AN AMBUSH STYLE ATTACK, I REFUSED, AND SLID THE TICKET UNDERNEATH HIS DOOR.
