Re: Freedom of Information Act Request

Dear Ms. Wroblewska:

On May 12, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "16-1016."

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a driver's license number, home or personal telephone numbers, home addresses, and a personal license plate, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, the name of a suspect who was not arrested, the name of a third party who incidentally appears in a police report, and the races of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, “[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes” are exempt from disclosure, “but only to the extent that disclosure would: ... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies.” Consequently, information that would reveal the identity of persons who filed complaints with or provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

ON 05-04-16 AT 1420 HOURS I WAS DISPATCHED TO 7743 W BELMONT TO TAKE A REPORT OF CRIMINAL DAMAGE TO VEHICLE. UPON ARRIVAL I MET WITH VICTIM/VEHICLE OWNER [REDACTED].

[REDACTED] DIRECTED MY ATTENTION TO HER VEHICLE, IL REG [REDACTED]. I NOTICED THE VEHICLE HAD MULTIPLE "KEY" MARKS ON IT. [REDACTED] STATED SHE HAD PARKED THE VEHICLE BEHIND HER BUILDING AT APPROXIMATELY 2015 HOURS ON 05-03-16. ON 05-04-16 SHE HAD RUN OUT TO THE VEHICLE AT APPROXIMATELY 0530 HOURS, BUT HAD NOT NOTICED THE DAMAGE AT THE TIME. SHE STATED IT WAS DARK AND RAINING AND SHE MAY HAVE INADVERTENTLY OVERLOOKED THE DAMAGE. SHE THEN TOOK THE BUS TO WORK. WHILE AT WORK AT 1102 HOURS SHE RECEIVED A TEXT MESSAGE FROM HER NEIGHBOR [REDACTED] WHO INFORMED HER OF THE DAMAGE. WHEN SHE RETURNED HOME AND CONFIRMED HER VEHICLE HAD BEEN DAMAGED SHE CONTACTED THE EPPD.

[REDACTED], WHO RESIDES IN APARTMENT [REDACTED], STATED SHE HAS HAD RECENT TROUBLES WITH HER NEIGHBOR IN APARTMENT [REDACTED]. [REDACTED] STATED THE TROUBLE BEGAN IN MARCH WHEN SHE NOTICED BED BUGS AROUND THE DOOR FRAME TO APARTMENT [REDACTED]. SHE NOTIFIED HER LANDLORD, [REDACTED], WHOM [REDACTED] STATED IS ALWAYS INTOXICATED, BECAME UPSET WITH [REDACTED] WHEN SHE LEARNED SHE HAD "TOLD ON HER." WHILE [REDACTED] WAS DOING LAUNDRY, [REDACTED] HAD TRIED TO PUNCH HER WHILE SHOUTING "YOU WHORE, YOU BITCH!" THE PREVIOUS ENCOUNTERS BETWEEN [REDACTED] AND [REDACTED] HAD BEEN REPORTED, EVENT #S 1633386 AND 1632852.

[REDACTED] STATED THAT ON 05-10-16 SHE WAS IN HER BATHROOM AND OVERHEARD [REDACTED] AND HER SON SPEAKING OUTSIDE. [REDACTED] ASKED HER SON "WHOSE CAR IS THAT?" [REDACTED] LOOKED OUT OF HER WINDOW AND OBSERVED [REDACTED] POINTING AT HER VEHICLE. [REDACTED] SON STATED THE CAR BELONGED TO [REDACTED] THEN STATED, "ITS THAT BITCH'S S."

[REDACTED] HAD NOT SEEN [REDACTED] DAMAGE HER VEHICLE, BUT FELT STRONGLY THAT SHE WAS RESPONSIBLE. [REDACTED] INTRODUCED ME TO HER NEIGHBOR [REDACTED] WHO RESIDES AT [REDACTED]. [REDACTED] INFORMED ME HE HAS A CAMERA SYSTEM THAT INCLUDES CAMERAS THAT FACE THE AREA OF INCIDENT. [REDACTED] ADVISED HE WOULD CHECK THE CAMERAS AND INFORM THE EPPD IF THEY HAD CAPTURED THE INCIDENT. [REDACTED] CAN BE REACHED AT [REDACTED]. I DID NOT OBSERVE ANY ADDITIONAL SURVEILLANCE SYSTEMS.

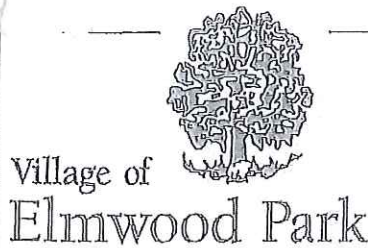
