# Village joins online program to track local crime

ELMWOOD PARK – Residents have a new way to track crime in their neighborhoods now that that village has partnered with SpotCrime.com. SpotCrime is a crime data aggregator which maps crime incidents and delivers alerts via email, text messages and social media.

"This is another measure we are taking to bring information to residents and help them know what's happening throughout our community," Elmwood Park Village President Angelo "Skip" Saviano said. "We have had an active community policing strategy (COPS) for some time. This is an additional way for residents to pull together and help police while also helping their neighbors as well."

The village will report information on criminal activity to SpotCrime on a daily basis. It will provide SpotCrime with the same statistics it reports to the FBI Uniform Crime Reporting (UCR) program which collects Part I offenses known to law enforcement and reports on persons arrested. In addition, SpotCrime uses data from news reports and user-generated content to provide information to the public.

Registration on SpotCrime.com is free. Residents are asked to enter their address and the radius of the area they wish to track, up to 25 miles from their home. They can choose to have alerts sent by email or as a text message or both.

SpotCrime is a nationwide program that's been mapping crimes for the past six years. "Having this additional information goes a long way to making our community safer," Saviano said. "The more people who are aware of what is occurring in a/our community, the better the chance we can, together, be proactive in our crime prevention efforts."

Saviano also encouraged residents to visit the village website <u>www.elmwoodpark.org</u> to sign up for Blackboard Connect, the village's program to alert residents to weather warnings, emergency notifications and also to stay connected to what's happening in the community. The service is free.
