Dear Ms. Menotti:

On Tuesday, April 26, 2016, our office received your April 15, 2016, correspondence concerning the additional records provided to you on April 7, 2016, in response to your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request that was received by the Village of Elmwood Park on March 7, 2016.

In your April 15, 2016, correspondence you state, "I just received the remainder records from your firm they are incomplete I just received only 14 pages out of 20, some were from another individual. That was not part of my case." Please be advised that on April 7, 2016, the Village of Elmwood Park provided you with all remaining pages of the records responsive to your FOIA request, which totaled fourteen (14) pages. As indicated in the Village of Elmwood Park's March 21, 2016, correspondence, your FOIA request consisted of sixty-four (64) pages of black and white letter sized pages. On March 21, 2016, the Village of Elmwood Park provided you with the first fifty (50) pages of records responsive to your FOIA request. The Village of Elmwood Park's production of the remaining fourteen (14) pages of records to you on April 7, 2016, completed the Village of Elmwood Park's response to your FOIA request. At no time did the Village of Elmwood Park advise you that you would expect to receive an additional twenty (20) pages of records responsive to your FOIA request.

In regards to your claim that records provided to you on April 7, 2016, "were from another individual," the Village of Elmwood Park has verified that the fourteen (14) pages of records sent to you on April 7, 2016, pertain to your FOIA request, and were not "from another individual." Attached for your reference please find the fourteen (14) pages of records that were


sent to you on April 7, 2016. Please be advised that the Village of Elmwood Park is providing you with duplicate copies of these records at no cost.
