Re: Freedom of Information Act Request

Dear Ms. Vivion:

On October 17, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "16-2327[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a home or personal telephone number, and a home address, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, a birthdate, and other personal information,

the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including the race of an individual, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

ON 09-22-16 AT 1817 HOURS I TOOK AN IN STATION REPORT OF A THEFT FROM ELIZABETH VIVION. ELIZABETH STATED A CHECK, #1202, HAD BEEN REMOVED FROM HER CHECK BOOK AND CASHED WITHOUT HER AUTHORIZATION.

ELIZABETH HAD ALREADY SPOKEN WITH HER BANK. SHE STATED THE CHECK WAS WRITTEN OUT TO CASH. THE CHECK WAS DATED 09-02-16 AND HAD BEEN CASHED AT AN UNKNOWN US BANK BRANCH ON 09-19-16. ELIZABETH STATED US BANK WOULD NOT PROVIDE HER WITH THE BRANCH THAT THE CHECK HAD BEEN CASHED AT, OR PROVIDE HER WITH AN IMAGE OF THE BACK OF THE CHECK SHOWING WHO HAD CASHED IT WITHOUT A POLICE REPORT. ELIZABETH STATED SHE HAD NOT LOST OR MISPLACED HER CHECK BOOK RECENTLY.

SHE STATED THAT ON 09-02-16 (THE DATE ON THE FRONT OF THE CHECK) SHE WAS AT HER JOB AT THE LEWIS SCHOOL, 1431 N LEAMINGTON, CHICAGO, IL. ON 09-02-16, NO STUDENTS WERE PRESENT AS IT WAS A STAFF DEVELOPMENT DAY. SHE WAS AT THE SCHOOL BETWEEN 0900 AND 1500 HOURS. SHE STATED THAT ON 09-02-16 HER CHECKBOOK HAD BEEN IN HER BAG AT WORK.

ELIZABETH WAS UNSURE IF THE CHECK MAY HAVE BEEN STOLEN FROM HER CHECK BOOK AT A DIFFERENT TIME/LOCATION.
