**Re: Freedom of Information Act Request**

Dear Mr. Cepeda:

On September 29, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "03-16969[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including social security numbers, driver's license numbers, home or personal telephone numbers, home addresses, and signatures, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the races of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency

for law enforcement purposes” are exempt from disclosure, “but only to the extent that disclosure would: ... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies.” Consequently, information that would reveal the identity of persons who filed complaints with or provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

The following is a summary of my actions relative to the investigation of a Battery that was reported on 12-06-03 at 2100 N. Harlem Avenue, Elmwood Park, Cook County, Illinois, 60707. Any witness and/or suspect statements contained herein are not in their entirety nor verbatim.

On 12-07-03 at 1530 hours I interviewed [REDACTED] at the station. [REDACTED] told me that on 12-05-03 he went to Baciemi at about 1930 hours. He said he had eaten there and he believed he had one alcoholic beverage. He said that at about 0030 hours a fight broke out and several people that he knew were involved. He said he recognized Eric Roque and Rocco Pretsi among the combatants. He said that Eric spotted him and punched him twice in the face. He said he was not involved in the fight, but he believed Eric punched him because they have had problems in the past. He said that Baciemi's bouncer grabbed him before he could retaliate. He said all the patrons were cleared from Baciemi following the fight. He said that he knew Eric Roque from previous encounters in the past. He said Eric started fights with him in the past. He said Eric and his friends are always starting fights at area bars.

[REDACTED] said he left Baciemi and went to his friend's apartment located at 2100 N. Harlem. He said the apartment belonged to [REDACTED] and [REDACTED]. He said that when he arrived [REDACTED] sister, [REDACTED] was at the apartment along with [REDACTED] brother, [REDACTED]. He said he talked and watched television in the living room with [REDACTED] while [REDACTED] slept on the couch nearby.

[REDACTED] said he was at the apartment about twenty minutes when the doorbell rang. He said he went to the locked exterior entrance door and saw Rocco Pretsi outside the door. He asked Pretsi what he wanted and Pretsi told him that [REDACTED] had invited him over and that he was to wait for her at the apartment. He said he opened the door to let Pretsi in because he knew that Pretsi has been to the apartment in the past and that he was friendly with [REDACTED]. He said that as soon as he opened the door Pretsi tried to grab him and punch him. [REDACTED] said he saw that there were about eight guys standing behind Pretsi when he opened the door. He said he ran back down the stairs and into the apartment as Pretsi followed him. He said that he recognized two other men there as Eric Roque and one of Roque's brothers (he was unsure of the name). [REDACTED] said that he was thrown into a glass table and on top of [REDACTED] who had just woken up. He said that Rocco, Eric and the other were punching and kicking him. He said that [REDACTED] was also being hit but he did not see who hit [REDACTED] specifically. He said the light was on prior to the incident but the switch must have been hit when the altercation spilled into the apartment. He said that [REDACTED] was yelling at the men stop hitting him and [REDACTED]. He said that the incident



The following is a summary of my actions relative to the investigation of a Battery that was reported on 12-06-03 at 2100 N. Harlem Avenue, Elmwood Park, Cook County, Illinois, 60707. Any witness and/or suspect statements contained herein are not in their entirety nor verbatim.

On 12-07-03 at 1645 hours I interviewed [REDACTED] at the station. [REDACTED] told me that on 12-06-03 she was at her sister's apartment located at 2100 N. Harlem Avenue with her sister's roommate's brother, [REDACTED]. She said that at about 0200 hours [REDACTED] came to the apartment. She said he appeared intoxicated. She said [REDACTED] told her that he got into a fight with Eric Roque at Baciama Café and they were thrown out. She said he told her that Eric had made a comment to him about Elmwood Park guys "are pussies." She said [REDACTED] told her that he and Eric exchanged words then started fighting. [REDACTED] said that she knows Eric Roque and has been to his residence in the past.

[REDACTED] said that about twenty minutes after [REDACTED] arrived the doorbell rang. She said she was going to see who it was but [REDACTED] told her he was expecting someone and that he would answer the door. She said that she stood in the apartment doorway and watched [REDACTED] go to the exterior door. She said that she saw Rocco Pretsi through the door as [REDACTED] spoke to him. She said [REDACTED] had the door open and she heard Rocco say something about [REDACTED] (one of the apartment tenants) inviting him over. She said she then saw Rocco push [REDACTED] and about eight guys come through the door after Rocco. She said they pushed [REDACTED] back down the stairs and into her causing all of them to enter the apartment. She said the men began beating on [REDACTED] and then eventually [REDACTED] who had been sleeping up to the point when the men entered the apartment. She said [REDACTED] was pushed onto a glass table and the table overturned, but was not damaged. She said that a table lamp was knocked over when [REDACTED] was pushed into the couch where [REDACTED] was lying. She said she kept trying to get the men to stop beating [REDACTED] and [REDACTED]. She said she yelled that [REDACTED] was only sixteen. She said one of the men said, "Oh shit," then they left.

She said Eric and Eddie Roque used to live in Chicago, Anderson lived in



The following is a summary of my actions relative to the investigation of a Battery that was reported on 12-06-03 at 2100 N. Harlem Avenue, Elmwood Park, Cook County, Illinois, 60707. Any witness and/or suspect statements contained herein are not in their entirety nor verbatim.

On 12-08-03 at 1200 hours Ofc. Frasco and I interviewed David E. Parolin at Holy Cross High School in River Grove. Parolin is employed as an English teacher at the high school. [REDACTED] provided us with a private conference room in which to conduct the interview.

I introduced myself and Ofc. Frasco to Parolin and I told him that we were investigating an incident that occurred on 12-06-03 at 2100 N. Harlem. I told Parolin that he was identified as one of the offenders involved in the incident by a battery victim. I advised him that several men battered [REDACTED] and that [REDACTED] identified him as one of the men present at the scene. [REDACTED] said that he was not directly involved in the incident but that he had knowledge that several of his friends were involved in a bar fight on that day. Parolin said he saw [REDACTED] prior to our interview and that he wasn't aware that his friends battered [REDACTED]

Parolin told us that on 12-06-03 he was in Melrose Park drinking at a bar when he where he met up with Eric Roque. He said Roque asked him to take him to Boca Café in Elmwood Park because there was going to be a fight. Parolin said he drove to Boca with the following persons:

Eddie Roque  
Eric Roque  
Rocco Pretzie

He said that when they got to Boca it appeared closed so they did not go in. He said that Eric Roque asked him if he could use his car to go look for the person he was supposed to fight. Parolin said he did not want Eric to drive his car so he drove Eric, Eddie and Rocco. He said he drove to the area of Phil's Sports bar and he parked east of Harlem on Dickens Avenue. He said Eric, Eddie and Rocco took off their watches and exited the car. He said that a short time later they got back into the car and they told Parolin to drive away.

Parolin said he found out from his friends that they beat up [REDACTED] and another person. He said that he did not know that Eric, Eddie and Rocco went to the apartment building looking for [REDACTED] and that he assumed they were going to meet



someone at Phil's. He said that he has known [REDACTED] for a long time and that he considers [REDACTED] a friend. He said that he would have refused to go with if he knew what was going to happen. He said he was surprised to learn that they also beat up [REDACTED] a student at his school. He said that he would have taken action to stop this from occurring if he knew who was involved and that they were going to be fighting.

Parolin insisted that he did not exit his vehicle at any time during this altercation. Parolin said that he would cooperate with our investigation and that he might seek the counsel of an attorney because of his status as a teacher at the high school, and the fact that a student at his school was the victim of this incident.

I advised Parolin that he should not have any contact with [REDACTED] outside of what was necessary for school business and that eh should also not contact [REDACTED] until the investigation is concluded.
