Dear Mr. Toner:

On September 6, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"Specifically under FOIA I am requesting copies of any and all liquor licenses, all liquor license applications, gaming establishment licenses, and gaming establishments license applications for all Blackhawk Restaurant locations.

Specifically under FOIA I am requesting copies of any and all liquor licenses, all liquor license applications, gaming establishment licenses, and gaming establishments license applications for all Lucy's Place locations."

Enclosed please find the following records responsive to your FOIA request: liquor licenses, liquor license applications, and gaming establishment licenses for all Blackhawk Restaurant and Lucy's Place locations. Additional time is required to provide you with the gaming establishment license applications responsive to your FOIA request, and will be made available to you by next week. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person."

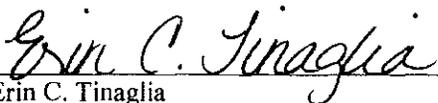

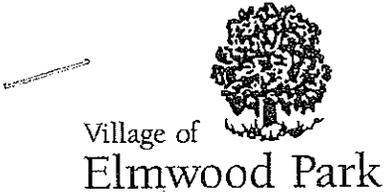
