Re: Freedom of Information Act Request

Dear Ms. Chatman:

On September 13, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "16-2134[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including home or personal telephone numbers, home addresses, and a personal license plate, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the races of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes" are exempt from disclosure, "but only to the extent that disclosure would: ... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies." Consequently, information that would reveal the identity of persons who filed complaints with or provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

On August 31, 2016, at 2011 hours, while at the 7400 block of North Avenue, completing a traffic crash report sitting in my marked squad, a male subject approached.

The male said while driving a U-Haul truck he rented, a vehicle has been following him.

The male said the vehicle is now stopped behind the U-Haul.

I notified communications of a disturbance and requested back-up units.

I approached the vehicle, Illinois registration [REDACTED] and spoke to the driver now identified as Gabriel Ware F [REDACTED]

Gabriel said she followed the U-Haul truck because the driver wearing a black shirt, is the one who murdered her fiance.

Gabriel said she has been in contact with the Chicago Police and updating them of this subject.

Commander Busch and Sergeant Brown arrived.

Sergeant Brown spoke to Gabriel.

I then gathered the occupants information:

Rear passenger behind driver: Ericka Little F [REDACTED]

I walked over to the U-Haul truck and spoke to the male that approached me, [REDACTED] M [REDACTED] and passenger [REDACTED] M [REDACTED].

[REDACTED] said he never met any of the occupants in the vehicle that followed him.

[REDACTED] said he did not call police and stopped when he noticed my squad.

[REDACTED] said he was moving furniture for his sister.

[REDACTED] said he works for Chicago streets and sanitation as a garbage truck worker in the 24th ward.

I spoke to [REDACTED]

[REDACTED] said he never met the occupants in the the black vehicle.

[REDACTED] said he did not call police.

I stood by [REDACTED] and [REDACTED] while Commander Busch and Segeant Brown spoke to the occupants of the vehicle.

Chicago Police arrived.

I spoke to CPD Officer Tracey and Officer Romero.

Ware, Taylor, Little, and Webb were placed under arrest.

[REDACTED] and [REDACTED] were sent on their way.

Tracey and Romero transported Ware, Taylor, Little, and Webb to our station.

Tracey performed female custodial searches on Ware, Little, and Webb.
