Re: Freedom of Information Act Request

Dear Mr. Ocasio:

On April 10, 2017, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"16-2448"

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1) (b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including employee identification numbers, home or personal telephone numbers, and home addresses have been redacted from the records being provided.

Section 7 (1) (c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ..." is exempt from disclosure. Consequently, birthdates, an individual's race, a victim's name and identifying information, the names of suspects who were never arrested, third party's identifying information, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, have been redacted from the records being provided.

INFORMATION FOR THE POLICE

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

On 10/06/16, at 1344 hours, I responded to 7545 Marwood Avenue for a harassment by telephone report, later classified as information for police.

Upon arrival, I spoke to Roberto Ocasio in front of his residence. Roberto told me the following. Roberto is separated from [REDACTED] no longer lives with him. Roberto has been making attempts to contact [REDACTED] regarding one of their vehicles. On Monday, October 03, 2016, Roberto called the telephone number known to him as [REDACTED] cell phone number. A woman answered the phone identifying herself as Carmen [REDACTED] friend). Carmen said to stop calling the number because it no longer belongs to [REDACTED]. On October 06, 2016 at 1318 hours, Roberto sent [REDACTED] cell phone number a text message. At 1321 hours, a male called Roberto's cell phone from a different number [REDACTED]. The male identified himself as [REDACTED] boyfriend, [REDACTED]. Robert told Roberto to stop calling the number because it belonged to his girlfriend, [REDACTED]. [REDACTED] told Roberto he was unaware [REDACTED] was still married. [REDACTED] told Roberto that if he did not stop calling "something is going to happen." Roberto told [REDACTED] he wanted to speak to him in person but [REDACTED] refused to meet in person. Roberto did not appreciate [REDACTED] getting involved in his marital issues.

I gave Robert the report number.
