Re: Freedom of Information Act Request

Dear Ms. Hausman:

On April 17, 2017, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"17-620"

Your request has been denied.

Section 7 (1) (d) (i) of FOIA provides that, "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes..." are exempt from disclosure, "but only to the extent that disclosure would...interfere with pending or actually and reasonably contemplated law enforcement proceedings conducted by any law enforcement...agency....." Consequently, information that would interfere with the pending law enforcement proceedings by the Village of Elmwood Park Police Department has been withheld. Please make a subsequent FOIA request once the investigation has been concluded.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. You can file your Request for Review with the Public Access Counselor by writing to:


