RE: Freedom of Information Act Request

Dear Mr. Giordano,

The Village of Elmwood Park is in receipt of your August 28, 2017, Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") for the following records:

"All correspondence and notices related to notification of need to enter 2209 N. 78th Ave, Elmwood Park, Il 60707 (Giordano Residence) including proof of service"

Enclosed are copies of the records you requested. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee id number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses." Section 7(1)(c) of FOIA provides that, "personal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy is exempt from disclosure. Consequently, birthdates and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, such as the victim's name and identifying information, have been redacted from the records being provided.

In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office.

You can file your Request for Review with the Public Access Counselor by writing to:

If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor. You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section II of FOIA.

Sec. 51-39: Location; Right Of Entry To Read, Etc.: 🖺 🖃

Water meters shall be located at such places, within or without the premises, and in such manner as the water department shall direct. Boxes or vaults in which meters are to be placed shall be made in accordance with specifications to be prescribed by the bureau of water. If any water meter is installed or located within any building, structure or premises, the owner or person in possession, charge or control thereof shall at all times permit the superintendent of water or any duly authorized person free entry, for the purpose of examining, testing, reading or repairing such meter, and in the event that such owner or person in possession, charge or control of such premises shall refuse or fail to permit such entry or shall in any way obstruct or cause to be obstructed such entry, the water supply to such premises shall forthwith be cut off. (1943 Code, § 803.03.)

Dear Water Customer:

It's time to change the AMR (Automatic Meter Reading) device attached to the water meter for your property at 2209 78TH AVE. In an overall effort to better serve our residents, the Village of Elmwood Park has implemented this replacement program as part of our ongoing water meter maintenance program. All water meter AMR devices in the Village, which were installed eleven years ago, now need to be replaced. Your device is included in the area of the Village being replaced this month.

This portion of the project is scheduled for completion within the next six weeks. Residents are requested to call the Account Manager for the replacement project, M.E. Simpson Company, at (Toll Free 1-888-252-1521) to set up an appointment to replace the AMR device. Appointments may be made for Tuesday through Saturday from 8:00 a.m. to 4:00 p.m. and Tuesday & Thursday evenings from 4:00 p.m. to 6:00 p.m... Residents are requested to make appointments upon receipt of this letter. The replacement is expected to take less than half an hour.

Your AMR device is likely mounted several feet above your water meter. If your meter is in your basement or crawl space, the AMR device will be located up in or near the floor joists or ceiling. If your water meter is located above ground in a closet or utility room the AMR device is likely located just above the water meter. As the installers from Calumet City Plumbing will need to access your water meter, as well as your AMR device, it's very important that you make both units accessible.

Each Calumet City Plumbing representative will present an Elmwood Park identification card to residents before asking to enter the home. Do not admit anyone into your home that does not have a picture identification card. If you are not sure whether the individual works for Calumet City Plumbing, you may call M.E. Simpson Company at (888) 252-1521 to verify the installer's name and installer number.

Water customers will not be billed for the AMR replacement. The Village will pay the cost of the new device and the installation.
