**Re: Freedom of Information Act Request**

Dear Mr. Rodriguez:

On February 24, 2017, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"17-434"

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1) (b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including names employee identification numbers, home or personal telephone numbers, and home addresses, have been redacted from the records being provided.

Section 7 (1) (c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ..." is exempt from disclosure. Consequently, birthdates, minors' information, an individual's race, a victim's name and identifying information, the names of suspects who were never arrested, a third party's information, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, have been redacted from the records being provided.



ON 02/16/17, AT APPROXIMATELY 1308 HOURS, I WAS ASSIGNED A STATION REPORT IN REFERENCE TO IDENTITY THEFT.

I SPOKE TO DAVID R RODRIGUEZ, (REDACTED) WHO STATED AN UNKNOWN PERSON USED HIS SOCIAL SECURITY NUMBER WITHOUT AUTHORITY AND WITHOUT HIS KNOWLEDGE TO OPEN AN ACCOUNT WITH COMCAST SOMETIME DURING THE MONTH OF SEPTEMBER 2016. DAVID STATED HE WAS RECENTLY NOTIFIED OF THIS APPROXIMATELY 1 WEEK AGO (WEDNESDAY, 02/08/17) WHEN HE RECEIVED A DEBT COLLECTION LETTER FROM "THE OFFICES OF CREDIT MANAGEMENT, LP." THE LETTER STATED HIS UNPAID DEBT WAS IN THE AMOUNT OF \$531.53. DAVID STATED HE SPOKE TO A REPRESENTATIVE FROM COMCAST WHO TOLD HIM THE ACCOUNT WAS OPENED USING HIS NAME, SOCIAL SECURITY NUMBER AND ADDRESS OF 5042 N. EERIE ST. DAVID STATED HE HAD NEVER LIVED AT THE NOTED ADDRESS AND WAS UNAWARE OF ITS LOCATION. DAVID STATED HE NEEDED A POLICE REPORT FILED SO COMCAST COULD START A FRAUD INVESTIGATION.

DAVID PROVIDED ME WITH A COPY OF THE LETTER HE RECEIVED FROM "THE OFFICES OF CREDIT MANAGEMENT, LP" FOR THIS REPORT.

I PROVIDED DAVID WITH A COPY OF THE IDENTITY THEFT PACKET AND ALSO PROVIDED HIM WITH A REPORT NUMBER AND INSTRUCTIONS.

I COMPLETED ALL PAPERWORK AND RETURNED TO DUTY.
