Re: Freedom of Information Act Request

Dear Mr. Jones

On February 9, 2017, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"17-328"

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1) (b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, VIN, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including driver's license numbers, names attributable to home address, employee identification numbers, home or personal telephone numbers, and home addresses have been redacted from the records being provided.

Section 7 (1) (c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ..." is exempt from disclosure. Consequently, birthdates, an individual's race, a victim's name and identifying information, the names of suspects who were never arrested, and other personal information, the

disclosure of which would constitute a clearly unwarranted invasion of personal privacy, have been redacted from the records being provided.

Section 7 (1) (d) (iv) of FOIA provides that, “[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes...” are exempt from disclosure, “but only to the extent that disclosure would...unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies...” Consequently, information that would reveal the identity of persons who have filed complaints with or who have provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. You can file your Request for Review with the Public Access Counselor by writing to:

If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

On 02/04/17 at 2214 hours, Officer Chaurize and I were dispatched to 7929 Belmont Avenue, Apt. #2 for a domestic disturbance. Upon arrival, I made contact with the caller [REDACTED] stated her husband [REDACTED] just left the apartment possibly out of the back door wearing only a tee shirt and shorts.

[REDACTED] stated around 2000 hours, she and [REDACTED] were verbally arguing with one another. [REDACTED] mentioned [REDACTED] was highly intoxicated, continued to yell swear words, and mentioned he wanted to kill himself. [REDACTED] stated she has had enough of their marriage and was ready for a divorce which is why [REDACTED] is so upset. [REDACTED] stated [REDACTED] continued to scream and yell and she did not feel comfortable with him in the apartment so she tried to call the police. As [REDACTED] attempted to call the police, [REDACTED] tried to stop her from making the phone call. [REDACTED] stated [REDACTED] eventually calmed down and she decided she did not need police assistance anymore. [REDACTED] left the apartment.

At 2214 hours, [REDACTED] was inside her bedroom with her door locked. [REDACTED] heard [REDACTED] enter the apartment and he immediately went toward [REDACTED] s bedroom. [REDACTED] was screaming and crying asking for [REDACTED] to open the door so they could talk. [REDACTED] then started pounding on the door repeatedly. [REDACTED] then called the police. [REDACTED] left out of the back door to the apartment complex on foot. [REDACTED] stated [REDACTED] never became physical tonight, only verbal.

Officer Chaurize and I searched the area with negative results of [REDACTED]

Approximately ten minutes later, [REDACTED] called the police again stating [REDACTED] is in the apartment screaming in pain about chest problems. Officer Chaurize and I located [REDACTED] on the back stairs of the apartment. [REDACTED] was screaming for help and complaining about his chest while he laid down on the stairs.

Paramedics #944 arrived on scene along with Officer Marchi.

[REDACTED] was taken into the ambulance to be transported to Gottlieb Hospital. Officer Marchi followed #944 to the hospital.
