On January 13, 2017, the Village of Elmwood Park received your January 12, 2017, Illinois Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") request for the following records:

- Identify the dates of employment history, position history and salary history of Mark Lymperopulos while employed by the Village of Elmwood Park.
- A copy of the job application of Mark Lymperopulos. 2.)
- 3.) A copy of the job posting with description of duties that Mark Lymperopulos was hired to fill.
- Identify the employee who held the position Mark Lymperopulos is employed to do prior to Mark Lymperopulos.
- A copy of all inquiries to the Village of Norridge regarding Mark Lymperopulos' employment with the Village of Norridge and a copy of all responses to said inquiries.
- Identify all Village of Elmwood Park vehicles that Mark Lymperopulos is assigned to drive and those available to him to drive.
- A copy of all accident reports involving Mark Lymperopulos while driving Village of Elmwood Park vehicles and a copy of all accident reports received from the Village of Norridge involving Mark Lymperopulos driving Village of Norridge vehicles.

8.) A copy of all inquiries to the State of Illinois Secretary of State regarding Mark Lymperopulos accident history while employed by the Village of Norridge[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including home or personal telephone numbers, home addresses, a personal email address, and signatures, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, a birthdate, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including the names of third parties that incidentally appear in records, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office.
