**Re: Freedom of Information Act Request**

Dear Ms. Uruchima:

On June 5, 2017, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"17-00611  
any reports or file agains [*sic*] me 5-31-17around 11<sup>00</sup>  
6-3-17 around 11<sup>00</sup>[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a driver's license number, home or personal telephone numbers, home addresses, and a personal license plate, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy" is exempt from disclosure. Consequently, personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, the

name of a suspect who was never arrested, the name of third parties who incidentally appear in police reports, and the races of individuals, have been redacted from the records being provided.

Section 7(1)(d)(iv) of FOIA provides that, “[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes” are exempt from disclosure, “but only to the extent that disclosure would... unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies.” Consequently, information that would reveal the identity of persons who filed complaints with or provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

On 03/09/2017, I responded to the Elmwood Park Police Department lobby to speak with [REDACTED] (F [REDACTED]).

[REDACTED] reported a male white subject she knows as [REDACTED], driving IL [REDACTED] was behind her garage in the alleyway on yesterday's date, 03/08/2017, at approximately 1515 hrs, when she was returning home after picking up her children from school.

[REDACTED] recognized [REDACTED] from a previous encounter in the City of Chicago, when he identified himself then as a former police officer.

[REDACTED] is fearful of [REDACTED] because she does not know how he could have obtained her home address other than through possible police contacts.

[REDACTED] has been taking care of [REDACTED] (F [REDACTED]), a friend she met when she used to be an employee at a bank, and has known [REDACTED] for approximately 12 yrs. [REDACTED] said she has been a form of caretaker for [REDACTED] and [REDACTED] recently passed away husband for the last 5 yrs, to include holding power of attorney paperwork for [REDACTED].

[REDACTED] said [REDACTED] (M [REDACTED]) used to know [REDACTED] and her husband in the past, but became unreachable for many years, including not attending [REDACTED] husband's recent funeral. [REDACTED] said [REDACTED] became angry and cut contact with [REDACTED] and her husband after he was told that possessions and money would be left to [REDACTED] after the couple passed away.

[REDACTED] said that [REDACTED] has threatened her in the past and that he is friends with [REDACTED] who was driving IL [REDACTED], after she seen the subjects together inside the same vehicle at [REDACTED] residence.

[REDACTED] said she called Chicago Police before when [REDACTED] and [REDACTED] were outside [REDACTED] residence in Chicago, but [REDACTED] identified himself as a retired police officer to the responding officers, and she believes they did not want to pursue the matter any further because of that.

[REDACTED] became tearful and said she is afraid for her and her family's safety. She said she would be calling her attorney for further advice.

I advised [REDACTED] I would document what she told me, provided her with this report number, and advised her to call 911 immediately if she or her husband observe either subject or the vehicle near her residence.
