Re: Freedom of Information Act Request

Dear Ms. Skwerski:

On December 27, 2016, the Village of Elmwood Park received your Illinois Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for "# 16-2684[.]"

Enclosed please find the records responsive to your FOIA request. However, please be advised that certain information in the records responsive to your FOIA request has been determined to be exempt from disclosure under FOIA. Accordingly, such information has been redacted from the records being provided.

Section 7(1)(b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, including a driver's license number, home or personal telephone numbers, home addresses, and personal license plates, have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal

privacy” is exempt from disclosure. Consequently, birthdates, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including the races of individuals, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. You can file your Request for Review with the Public Access Counselor by writing to:



On 10/31/2016, at approximately 1215 hrs, I spoke with Laura M Skwerski (F [REDACTED]) at the police department regarding a minor traffic crash in the parking lot at 2828 N Harlem Ave. on today's date.

Laura reported she was backing out of a parking space in the parking lot when IL [REDACTED] attempted to pass her, striking the front driver side of Laura's vehicle (IL [REDACTED]). Laura advised the striking vehicle had front passenger side surface damage. Laura said she dialed 911 and the operator advised she exchange information with the other driver and they schedule a time to report to the police department to make a report.

Laura said the other driver, described as an older white female, short and stocky, with an accent, began yelling at Laura, saying the crash was Laura's fault. The other driver then returned to her vehicle and left the area.

Laura said she wanted the incident documented in the event the other driver attempts to file a report against Laura.
