There are a total of sixteen (16) Illinois Traffic Crash Reports responsive to your FOIA request. Therefore, pursuant to Section 11-416 of the Illinois Vehicle Code (625 ILCS 5/11-416), please remit payment to the Village of Elmwood Park in the amount of Eighty and 00/100ths Dollars (\$80.00). Upon receipt of your payment, the Village of Elmwood Park will provide you with copies of the accident reports responsive to your FOIA request.
