Re: Freedom of Information Act Request

Dear Ms. Nguy:

On November 17, 2017, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"In November 1916 N. Harlem #2N"

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1) (b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2 (c-5). Consequently, certain unique identifiers, such as home or personal telephone numbers and home addresses have been redacted from the records being provided.

Section 7 (1) (c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ..." is exempt from disclosure. Consequently, birthdates, an individual's race, a victim's name and identifying information, the names and identifying information of suspects who were never arrested, third party's name and identifying information, a minor's name and identifying information, and other personal

information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, have been redacted from the records being provided.

Section 7 (1) (d) (iv) of FOIA provides that, "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes..." are exempt from disclosure, "but only to the extent that disclosure would...unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies..." Consequently, information that would reveal the identity of persons who have filed complaints with or who have provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. You can file your Request for Review with the Public Access Counselor by writing to:

If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

On 10-28-17 1015 hours, Ofc Geraci and I responded to 1916 Harlem Av for a battery report.

On scene I spoke to [REDACTED] who told me he is [REDACTED] for this building which is owned by [REDACTED]. He came to scene to collect tools to do work at a different location when he is confronted by a tenant of the second floor [REDACTED] with [REDACTED] was very upset with him over ongoing issues with the heating unit not working properly and was yelling at him with [REDACTED]. During this [REDACTED] grabbed [REDACTED] on his arm and told him "Do not talk to my girlfriend like that." [REDACTED] told [REDACTED] not to touch him, pulled out his cell phone and started recording [REDACTED] said [REDACTED] demeanor completely changed and [REDACTED] then called the police. [REDACTED] said he did not wish to pursue criminal complaints against [REDACTED] but wished to obtain an order of protection. I provided [REDACTED] with this report number for his records.

Ofc Geraci spoke to [REDACTED] and [REDACTED] to explained they were upset with the way the landlord was treating them and were not satisfied with the building's heat. Ofc Geraci explained their options to him and requested they avoid physical confrontations or potentially be arrested.
