Re: Freedom of Information Act Request

Dear Mr. Fumo:

On April 16, 2018, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"Police report/arrest report/incident report for call to 7840 W. North Ave at approximately 7:35 am Sunday April 15, 2018."

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1) (b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers such as driver's license numbers, home or personal telephone numbers, and home addresses have been redacted from the records being provided.

Section 7 (1) (c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ..." is exempt from disclosure. Consequently, birthdates, an individual's race, a minor's name and identifying information, a victim's name and identifying information, the name and identifying information of suspects who were never arrested, third party's name and identifying information, and other personal

information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, have been redacted from the records being provided.

Section 7 (1) (d) (iv) of FOIA provides that, "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes..." are exempt from disclosure, "but only to the extent that disclosure would...unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies..." Consequently, information that would reveal the identity of persons who have filed complaints with or who have provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. You can file your Request for Review with the Public Access Counselor by writing to:

If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY

ON 04/15/2018 AT 0812 HOURS I RESPONDED TO 7840 W. NORTH AVE FOR A CHECK WELL BEING NOW RECLASSIFIED AS CRIMINAL DAMAGE TO PROPERTY, THE CALLER [REDACTED] REPORTED A FEMALE IN THE COMMON HALLWAY OF THE BUILDING AND DAMAGE TO THE GLASS SECURITY DOOR.

UPON MY ARRIVAL I SAW AN UNKNOWN SUBJECT WITH A GRAY HOODIE AND BLUE JEANS BENT OVER AT THE WAIST RESTING IN THE COMMON AREA OF THE BUILDING. I ENTERED THE COMMON AREA OF THE BUILDING AND ANNOUNCED MY OFFICE AS A POLICE OFFICER. THE SUBJECT DID NOT REPLY. I AGAIN IDENTIFIED MYSELF AS A POLICE OFFICE AND WAS RESPONDED TO. THE SUBJECT SPOKE TO ME AND I WAS ABLE TO IDENTIFY THE HIM AS [REDACTED]

[REDACTED] TOLD ME HE HAD STOPPED AFTER WALKING A LONG DISTANCE FROM A CLUB. [REDACTED] SAID HE WAS COLD AND WET AND STOPPED IN THE BUILDING TO WARM UP. I QUESTIONED [REDACTED] ABOUT THE DAMAGED DOOR AND HE DENIED HAVING ANYTHING TO DO WITH THE BROKEN GLASS. HE WAS ABLE TO PRODUCE A ILLINOIS DRIVERS LICENSE AS IDENTIFICATION. [REDACTED] REQUESTED I GAVE HIM THE RIDE TO HIS HOME AT [REDACTED]. I OFFERED TO CALL A TAXI FOR [REDACTED] AND HE SAID YES. [REDACTED] SAID HE HAD ENOUGH CASH TO PAY FOR THE RIDE AND SHOWED ME HIS WALLET CONTAINING OVER \$50.00. A CAB WAS REQUESTED AND [REDACTED] WAS TAKEN HOME.

AS I INVESTIGATED THE DAMAGE OF THE DOOR I OBSERVED I OF SECURITY CAMERAS IN THE COMMON AREA OF THE BUILDING. AT THE TIME OF THIS REPORT I WAS NOT ABLE TO MAKE CONTACT WITH THE PROPERTY MANAGEMENT GROUP TO GET ACCESS TO THE CAMERA AND /OR SAVED VIDEO.
