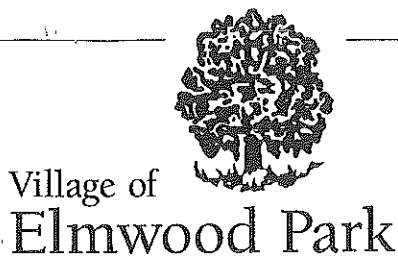

RE: Freedom of Information Act Request

Dear Mr. Martin,

The Village of Elmwood Park is in receipt of your June 13, 2018, Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") for the following records:

"Any outstanding balances for : 7417 West Fullerton Avenue, Elmwood Park, IL 60707 PIN #12-36-202-006-0000"

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1) (c) of FOIA provides that "personal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy..." is exempt from disclosure. Consequently, birthdates, and individual's race, a minor's name and identifying information, a victim's name and identifying information, the identifying information of suspects who were never arrested, third party's identifying information and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. If you choose to file a Request for Review with the Public Access Counselor, you must do so within 60 calendar days of the date of this letter. Please note that you must include a copy of your original FOIA request and this letter when filing a Request for Review with the Public Access Counselor.

You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

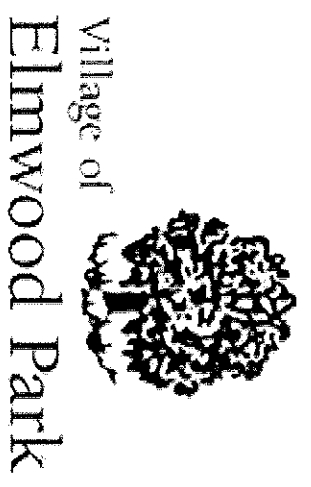
