On May 15, 2018, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"Copy of Plumbing Plans of permit work completed
Copy of electrical Plans for permit work completed
Copy of basement water tile system (drainage) completed for 2833 N. 72nd Ct Elmwood
Park, IL 60707"

Your request has been denied.

Section 7 (1) (k) of FOIA provides that "Architects' plans, engineers' technical submissions, and other construction related technical documents for projects not constructed or developed in whole or in part with public funds" is exempt from disclosure. As such, the plans you requested are exempt from disclosure as they were constructed and developed with private funds.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko.
