On October 19, 2018, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

Your request has been denied. Please be advised that the information has been determined to be exempt from disclosure under FOIA and that information has withheld.

Section 7.5 (bb) of FOIA provides that "[i]nformation which is or was prohibited from disclosure by the Juvenile Court Act of 1987" is exempt from disclosure. Consequently, information that is prohibited from disclosure under the Illinois Juvenile Court Act of 1987 has been withheld.


