Dear Mr. McMahan:

On April 18, 2019, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"Any and all reports regarding a report of burglary at 2641 N. 76th Ave, Elmwood Park, Il. on April 1, 2019 under Elmwood Park Police Dept report #19-743."

Your request has been denied.

Section 7.5 (bb) of FOIA provides that "[i]nformation which is or was prohibited from disclosure by the Juvenile Court Act of 1987" is exempt from disclosure. Consequently, information that is prohibited from disclosure under the Illinois Juvenile Court Act of 1987 has not been provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. 
