**Re: Freedom of Information Act Request**

Dear Ms. Zamudio:

On February 19, 2019, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"...the report for a complaint call made against my residence for loud noise disturbance ordinance # 1943, 1102.07 on 2/17/2019 at 1:00am by Officer 48. Resulting in violation # S645."

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1) (b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, VIN, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers, such as driver's license numbers and home or personal telephone numbers have been redacted from the records being provided.

Section 7 (1) (c) of FOIA provides that, “[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ...” is exempt from disclosure. Consequently, birthdates, minors’ name and identifying information, an individual’s race, a victim’s name and identifying information, a third party’s name and identifying information, the names of suspects who were never arrested, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General’s Office. You can file your Request for Review with the Public Access Counselor by writing to:



THE INFORMATION BELOW IS CONFIDENTIAL - FOR USE BY AUTHORIZED PERSONNEL ONLY		

On 02/17/19 at 0112 hours, Officer LaPenna and I were dispatched to 2010 73rd Court for a loud noise complaint coming from a refused caller. Upon arrival, I heard loud music coming from 2010 73rd Court. The music could be heard from a half of a block away. It took several minutes for the home owner to answer the door. Eventually I made contact with a male subject at the front door. I advised the subject the music was very loud and needed to be turned down for the remainder of the night. I then asked the subject for his name. The male subject was uncooperative, would not provide his name, and slammed the door shut. Seconds later, I observed the music to be turned louder than it was when I first arrived on scene. The male subject would not answer the door.

I then went into my squad and looked up the extensive call history at 2010 73rd Court and retrieved the name of the male subject, now identified as Jonathan Zamudio (m [REDACTED]). I issued Zamudio a local ordinance citation for loud noise, citation #S645. Zamudio continued to ignore the police at the front door and blast loud music. I left the citation in the mailbox and returned to duty.
