The Taste of Elmwood Park festival will return and we welcome you and your creative arts and crafts. The fest is scheduled for Thursday, August 9, 2018 – Sunday, August 12, 2018. The festival days and hours are: Thursday, August 9, 2018, 5:00 p.m. – 11:00 p.m., Friday, August 10th, from 5:00 p.m. - 11:00 p.m., Saturday, August 11th, noon – 11:00 p.m. and Sunday, August 12<sup>th</sup> from noon – 10 p.m.

Enclosed you will find a Taste of Elmwood Park Arts and Craft Application. Please know that we do expect full participation from each vendor and you are obligated to remain at the fest for the entire four days. The craft section is mapped out to accommodate all vendors. Please note that vendors are not to move from their pre-assigned location without checking with us and at no time should anyone touch or move another vendors belongings.

The entry fee is \$100.00. You will be allotted a 10' x 10' designated spot. You can only use the space that is designated as your area. The area will be well lite and you will be given the opportunity to hook up to one 20 amp 110 volt electrical service if are interested. Please remember that you are responsible to bring with you any and all supplies, tables, chairs, tent/canopy coverings, electrical cords, etc. **All vendors need to bring a tent so that the fest appearance is uniformed and your merchandise is weather protected.** It is mandatory that all vendors are present for all four days of the event.

Please be sure to complete the entire application and return it to the Village of Elmwood Park, 11 Conti Parkway, Arts and Craft Corner, Elmwood Park, IL 60707. All applications must be received by June 30, 2018 along with the entry fee.

Any extra supplies or products must be held in a secured area supplied by the vendor and approved by the fair directors and transferred to their booth when needed. No logos of any kind are to be sold at this festival. No inappropriate or adult rated products will be allowed. No refunds will be given once the application is approved. The Village of Elmwood Park holds the right to have the crafter removed from the fair if any of these violations or any additional violations are witnessed by the fair directors. The Village of Elmwood Park is not responsible for missing or stolen goods.**
