Dear Ms. Borkowicz:

On November 6, 2018, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 et seq.) ("FOIA") request for the following records:

"Please provide the seven (7) proposal responses submitted to the Village of Elmwood Park in reference to the RFP for solid waste, landscape waste and recyclable materials collection services issued June 15, 2018, and due on August 10, 2018.

We also would like copies of the four (4) additional proposals submitted through follow up meetings due on or around September 13, 2018.

In addition, we are requesting copies of the two (2) final proposals submitted by the final two (2) companies that met with Village Officials after Sept 13, 2018."

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted from the records being provided.

Section 7 (1) (b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number. driver's license number, VIN, employee identification number, biometric

identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers including signatures have been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office.
