**Re: Freedom of Information Act Request**

Dear Mr. Pearlman:

On May 11, 2020, the Village of Elmwood Park received your Freedom of Information Act (5 ILCS 140/1 *et seq.*) ("FOIA") request for the following records:

"...a copy of the Dog Bit Incident Report..."

Your request has been granted in part and denied in part. Enclosed are records responsive to your FOIA request. However, please be advised that certain information in the records being provided has been determined to be exempt from disclosure under FOIA, and that information has been redacted or withheld from the records being provided.

Section 7 (1) (b) of FOIA provides that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2 (c-5). Consequently, certain unique identifiers such as driver's license numbers, home or personal telephone numbers, home addresses, personal license plates, and signatures have been redacted from the records being provided.

Section 7 (1) (c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy ..." is exempt from disclosure. Consequently, birthdates, an individual's race, a victim's name and identifying

information, the names and identifying information of suspects who were never arrested, third party's name and identifying information, a minor's name and identifying information, and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, have been redacted from the records being provided.

Section 7 (1) (d) (iv) of FOIA provides that "[r]ecords in the possession of any public body created in the course of administrative enforcement proceedings, and any law enforcement or correctional agency for law enforcement purposes..." are exempt from disclosure, "but only to the extent that disclosure would...unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies..." Consequently, information that would reveal the identity of persons who have filed complaints with or who have provided information to the Village of Elmwood Park Police Department has been redacted from the records being provided.

The person responsible for the decision to deny a portion of your FOIA request is the Village of Elmwood Park Freedom of Information Officer, Gina Pesko. In accordance with Section 9(a) of FOIA, you are hereby notified that you have the right to file a Request for Review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer with the Public Access Counselor at the Illinois Attorney General's Office. You are also notified that you have the right to judicial review regarding the decision made by the Village of Elmwood Park Freedom of Information Officer pursuant to Section 11 of FOIA.

08/28/19 17:34, I was dispatched to a Dog Bite at 2415 78th Ct, Elmwood Park, IL 60707.

Upon arrival, I spoke with [REDACTED] stated [REDACTED] was bitten by dog earlier in the day at approximately 15:20. [REDACTED] learned of the incident after [REDACTED] came home from school with multiple abrasions on his upper body.

I spoke with [REDACTED] stated after school he was walking home when two dogs attacked him in front of 2041 76th Ave, Elmwood Park, IL 60707. [REDACTED] said he was bitten and scratched by the dogs. [REDACTED] was not sure if the dogs came from the front door or the backyard. [REDACTED] could only describe the dogs as a lighter color.

I observed multiple abrasions on [REDACTED] back and arms. (see attached photographs)

I attempted to make contact with the owner, later identified as James Boshold, at 2041 76th Ave but I was unsuccessful. I spoke with multiple residents on the block. The residents advised the two dogs were German Shepherds which are constantly getting loose from house.

08/29/19 10:54, Officer Brand #6017 followed up with James at 2041 76th Ave. (see Brand's report)

08/31/19 08:53, Officer Marino #223 and I attempted to make contact with James to issue citations but we were unsuccessful. I observed the dogs through the window of the door of 2041 76th Ave. The dogs appeared to be light brown German Shepherds.

I completed two Cook County Animal and Rabies Control Animal Bite Reports. I also completed a United States Postal Service Certified Mail Receipt for the citations to be issued to James via mail.

On 09/03/19 at approximately 1730 hrs, I was advised by desk officer Tristano that a resident wished to speak with a supervisor regarding a dog bite reported several days earlier.

I spoke with [REDACTED] who stated she was upset and concerned that her son was bit by the dogs, as outlined in the incident report, on 08/28/19 and there was no action taken towards ensuring the dogs did not have rabies. She stated she was told by a doctor that her son would soon have to be put under a series of shots if there was no information obtained regarding the status of the dogs. She stated she contacted Elmwood Grove Animal Hospital and spoke with the veterinarian who told her the dogs in question were not brought in following the bite. She stated she was asking for information.

I told [REDACTED] I would attempt to obtain information for her and call her back. She was provided with a report number.

I contacted the owner of the biting dogs James Boshold and spoke with him via phone. He stated he spoke with the Deputy Chief today and was told what steps he needed to take following the bite only today. He stated he took the dogs to the vet's office today but was told they could not be seen as no vet was on duty. He stated he had an appointment on tomorrow's date and would bring in the dogs to be examined by a vet tomorrow. He acknowledged he received ordinance citations.

I contacted [REDACTED] and advised her of my conversation with Boshold. I advised her that any enforcement of after bite procedures were handled by Cook County Animal Control. I advised her that according to the incident report, the Cook County bite cards were completed by the reporting officer and were to be sent out to Cook County Animal Control. I advised her of the hearing date of 10/03/19.
